John, you and a farmer have a common problem. If both of you don't plant seeds, there will be nothing to harvest.

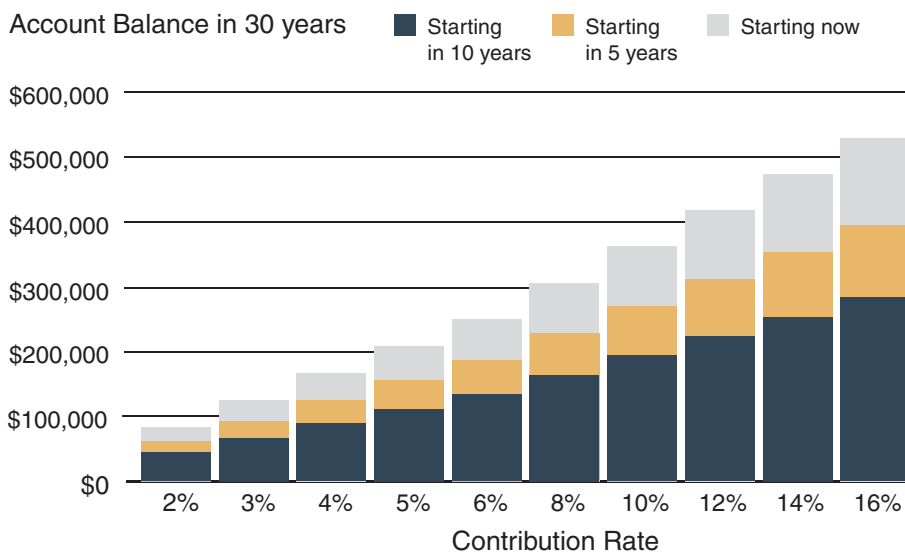
